## AN ORDINANCE TO AMEND ORDINANCE NO 7

## RELATING TO PROHIBITING THE ACCUMULATION OF GARBAGE, REFUSE AND TRASH UPON PROPERTY WITHIN THE CORPORATE LIMITS OF THE TOWN OF FRANKFORD AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF:

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF FRANKFORD,

SECTION 4: RELATING TO THE AMOUNT OF THE FINE NOT LESS THAN TWENTY- FIVE DOLLARS (\$25.00) NO MORE THAN ONE HUNDRED DOLLARS (\$100.00) OR IMPRISONED FOR A TERM OF NOT LESS THAN TEN (10) DAYS, OR BOTH, AND SHALL PAY THE COSTS OF PROSECUTION.

Amend to a fine of one hundred dollars (\$100.00) per month until corrected. Delete the imprisoned term, time and cost from ordinance.

SECTION 4: THIS ORDINANCE SHALL TAKE EFFECT ON THE DATE OF ITS ADOPTION.

## ORDINANCE NO. 7

AN ORDINANCE PROHIBITING THE ACCUMULATION OF GARBAGE, REFUSE AND TRASH UPON PROPERTY WITHIN THE CORPORATE LIMITS OF THE TOWN OF FRANKFORD AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF.

BE IT ORDAINED by the Town Council of The Town of Frankford, in Council met, in the manner following, to wit:

- SECTION 1. The accumulation of waste, refuse, trash and other deleterious substances on the premises of private residences, commercial institutions and in the streets and alleys greatly increases the danger of fire and spread of infections, contagious and epidemic diseases and shall constitute a public menace and nuisance.
- SECTION 2. For the purposes of this Ordinance, the following definitions shall be applicable unless the context clearly indicates to the contrary:
- (a) Garbage shall mean and include all waste, animal or vegetable, such as, but not limited to, waste material and refuse from kitchens, residences, grocery stores, butcher shops, restaurants, cafes, hotels, rooming houses and boarding houses and all other deleterious substances.
- (b) Person shall mean and include any individual, natural person, joint stock company, partnership, voluntary association, society, club, firm, company, corporation, crganization or any other group acting as a unit or the manager, lessee, agent, servant, partner, member, director, officer or employee of any of them,

including an executor, administrator, trustee, receiver or other representative appointed by law.

- (c) Refuse shall mean and include waste, rubbish, carbage, trash, or any other material of any kind that has been discarded, rejected, cast aside or thrown away as worthless, except body waste.
- (d) Trash shall mean and include rubbish such as feathers; coffee grounds, ashes, tin cans, paper, boxes, glass, wood, shrubs, yard clippings, leaves, tree trimmings and other similar matter.
- SECTION 3. It shall be unlawful for any person to accumulate or permit to be accumulated upon property owned or occupied by him within the corporate limits of The Town of Frankford any garbage, refuse or trash.
- SECTION 4. Any person violating any of the provisions of this Ordinance shall be deemd guilty of a misdemeanor and upon conviction thereof, shall have thirty (30) days to correct the condition for which he has been deemed guilty of a misdemeanor and, if the condition shall not be corrected within said thirty-day period, he shall be fined not less than Twenty-five Dollars (\$25.00) nor more than One Hundred Dollars (\$100.00) or imprisoned for a term of not less than ten (10) days, or both, and shall pay the costs of prosecution.
