

ORDINANCE NO 6

AN ORDINANCE TO AMEND ORDINANCE NO 6
RELATING TO PROHIBITING THE ACCUMULATION OF JUNK ON PROPERTY
WITHIN THE CORPORATE LIMITS OF THE TOWN OF FRANKFORD AND PRESCRIBING
PENALTIES FOR VIOLATION THEREOF.

BE IT ORDAINED by the Town Council of the Town of Frankford,

SECTION 1. Amend Ordinance No 6, Entitled: **AN ORDINANCE PROHIBITING THE ACCUMULATION OF JUNK ON PROPERTY WITHIN THE CORPORATE LIMITS OF THE TOWN OF FRANKFORD AND PRESCRIBING FOR VIOLATION THEREOF: SECTION 1:** Amend to the addition of items Furniture and Mattresses.

SECTION 3. Amend Ordinance No 6, Entitled: **AN ORDINANCE PROHIBITING THE ACCUMULATION OF JUNK ON PROPERTY WITHIN THE CORPORATE LIMITS OF THE TOWN OF FRANKFORD AND PRESCRIBING FOR VIOLATION THEREOF: SECTION 3:** Amend to the amount of time to dispose of the junk from ninety (90) days to thirty (30) days.

SECTION 3. AMEND ORDINANCE NO 6 ENTITLED: AN ORDINANCE PROHIBITING THE ACCUMULATION OF JUNK ON PROPERTY WITHIN THE CORPORATE LIMITS OF THE TOWN OF FRANKFORD AND PRESCRIBING FOR VIOLATION THEREOF: SECTION 3: Relating to the amount of the fine not less than twenty-five dollars (\$25.00) no more than one hundred dollars (\$100.00) or imprisoned for a term of not more than ten (10) days, or both, and shall pay the costs of prosecution.
Amend to a fine of one hundred dollars (\$100.00) per month until corrected.
Delete the imprison term, time and cost from the ordinance.

SECTION 4: THIS ORDINANCE SHALL TAKE EFFECT ON THE DATE OF ITS ADOPTION.

ORDINANCE NO. 6

AN ORDINANCE PROHIBITING THE ACCUMULATION OF JUNK ON PROPERTY WITHIN THE CORPORATE LIMITS OF THE TOWN OF FRANKFORD AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF.

BE IT ORDAINED by the Town Council of The Town of Frankford, in Council met, in the manner following, to wit:

SECTION 1. For the purpose of this Ordinance, the following definitions shall be applicable unless the context clearly indicates to the contrary:


(a) Junk shall mean and include old or scrap copper, brass, rope, rags, batteries, rubber, debris, waste, or junk, dismantled or wrecked automobiles or parts thereof, iron, steel and other old or scrap, ferrous or non-ferrous material, refrigerators, crates, boxes and other similar materials which have outlived their usefulness in their original form.

(b) Person shall mean and include any individual, natural person, joint stock company, partnership, voluntary association, society, club, firm, company, corporation, organization or any other group acting as a unit, or the manager, lessee, agent, servant, partner, member, director, officer or employee of any of them, including an executor, administrator, trustee, receiver, or other representative appointed by law.


SECTION 2. It shall be unlawful for any person to accumulate or permit to be accumulated upon any property owned or occupied by him any junk.

SECTION 3. Any person violating any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall have ninety (90) days to correct the condition for which he has been deemed guilty of a misdemeanor and, if the condition is not corrected within the said ninety-day period, he shall be fined not less than Twenty-five Dollars (\$25.00) nor more than One Hundred Dollars (\$100.00) or imprisoned for a term of not more than ten (10) days, or both, and shall pay the costs of prosecution.
